All of the editing tools available in Photoshop are available on each layer. (It's helpful to know that you can edit all the tools at once using the Edit Multiple Tool Options context menu.) If you change something on the layer's settings, that change also occurs when you select the tool. You can't paint or draw on multiple layers at the same time. Each layer gets its own bitmap buffer when you draw or paint on it. The layer you're working on always remains active; you can switch between the layers, but you can't paint, draw, or do any other type of drawing or painting on multiple layers at the same time. If you want to work on multiple layers, you have to merge them. After you create a composite, you're usually better off working on a single layer with all of the composites incorporated in your work. The Layers panel Photoshop's Layers panel is a visual representation of layers in your image. It's hidden by default; to display it, choose View » Layers to make it visible. Your layers exist in this panel, but any effect you choose to apply affects all layers in the image. To apply an effect or effect to only one layer, you must temporarily lock that layer's editing options using the Flatten Image button (the dialog box that appears when you select Edit Flatten Image or press Alt+Ctrl+F). This step unlocks the layer so that you can control its editing options or hide its contents from view. After you apply an effect to a locked layer, you can show the layer by unselecting the layer's check box. Click the Unlock button to make changes or select the Flatten Image button again to lock

III. The trial court held that the entire provision was invalid as being contrary to public policy. In his opinion filed below, trial judge, Judge Thomas, states: "The Illinois Motor Vehicle Safety Responsibility Law permits a party injured by a motorist without a valid and effective policy of insurance in effect at the time of the accident to choose to pursue one of several remedies available to him. Article 9-1(d)(1) of the Motor Vehicle Safety Responsibility Law provides a party injured by a motorist with two potential remedies, a private action against the motorist, or a suit against the motorist's insurance carrier for the amount of damages incurred in a third party action. If the injured party first pursues his remedy against the motorist, *479 and that proceeding is unsuccessful, he can then pursue his remedy against the motorist's insurance carrier. When a third party action against the motorist is successful, the injured party is entitled to recover the damages incurred in the third party action, less any amount which the injured party has received from the motorist. The Illinois law is clearly designed to promote an injured party's ability to recover damages from a third party and to collect damages not received from the motorist. In this case, the insurance carrier in question has paid the amount of the judgment in the third party action. To the extent that the potential insured was able to recover his damages from the insurer, he has lost that opportunity. In addition, in the event of this kind of situation, where a third party action is successful and the insured refuses to comply with the requirement of the Motor Vehicle Safety Responsibility Law that he post security for the judgment, the insurer would be completely discharged from the insured's liability for any amount to which he may be entitled.
